Dear Mr Bradley,

Further to your information request of 23 May 2023 seeking further information in relation to the Sites and Areas of Significance to Māori (SASM) notation on your land, we have processed your request as a request under the Local Government Official Information and Meetings Act (LGOIMA). The response to your request is set out below.

You are correct that your land is part of the submission by Ngai Tahu and the two Rūnanga, and that their submission seeks that the Hearing Panel amend SASM 104 to refine this area so it just captures the waterway and not any land parcels adjoining the waterway, which would include removal of your land.

Unfortunately it is not possible for staff to simply confirm it will be removed immediately. The requirements are that Ngai Tahu's submission will go through the legal process outlined in the First Schedule of the Resource Management Act, and will be considered by a panel of Commissioners. A decision on refining the areas of SASM 104 will be part of this process.

Given that your land is directly affected by SASM 104, with your agreement, WCRC staff can add a further submission in support of the Ngai Tahu submission points on your behalf. Please confirm whether you would like a further submission lodged.
