#### **Accomplishments this Period**

- The final two public meetings took place in Buller on 1 September. There was a great turn out in Westport, and I have received a number of emails commenting on the planners' calm professionalism. This is true for all of the public engagement undertaken on the proposed Plan, and I would like to add my thanks and praise for the team.
- The support from Committee members and council staff at the meetings was greatly appreciated and they made a very valuable contribution to many of the conversations.
- Over 380 people attended the 18 public meetings and 4 library sessions held by staff.
- During September the number of queries has reduced significantly, with the majority being from council planning staff as they work through the implications of TTPP provisions.
- Poutini Ngāi Tahu have continued to work in collaboration with the planning and GIS teams to update the TTPP maps. This has been a mammoth task and wouldn't have been achieved without the oversight and input of Philippa Lynch from Poutini Environmental. The updated maps were published on the TTPP website on Friday 16 September. Individual maps then had to be developed for each of the 216 SASM. Compilation of the individual SASM maps, letters and information began the week of 19 September, and the first letters were posted to landowners in the week of 26 September.
- Over a dozen information sheets have been produced to highlight some of the changes in different towns and settlements or explain what is happening on a specific topic such as mineral extraction. The information sheets are available on the TTPP website.
- The extension to the submission period has been advertised by public notice, contacts lists have been emailed about the change, as have central and local government contacts.
- Advertising is ongoing and will include the extension to the submission period.
- Online forms and information now advertise the new closing date and updated hard copies of the forms will be delivered to 19 venues along with updated maps and Plan text.
- There are no more meetings scheduled for the current Committee. I would like to thank the Committee for its hard work and support of the planning team over the past three years.
