We would like to see the protection of the Coastal Sand Dune Forest of AkaAka (*Dononaea viscosa*) which is one of the last remnants of this type of coastal forest remaining in NZ
(Ref: Prof. J. T Salmon - NZ Flowers - Plants First Pub 1963)

Extent:- This stand of forest is outside of the National Park boundary ie outside of existing fence line to the high tide line in width and extends in length from approx 500metres Nth of McMillans Rd (just Nth of Punakaiki) & extends North until it links with Te Wikaui Scenic Reserve. (approx 2km in length)
