**TE TAI o POUTINI PLAN**  
**SUBMISSION RE: SITE OF SIGNIFICANCE TO MĀORI**  
**(SASM 68 – PAROA LAGOON)**

We wish to advise that we **OPPOSE** the establishment of a Site or Area of Significance to Māori (SASM 68 – Paroa Lagoon) in its current format.

While it is recognised that extensive work has been undertaken by Poutini Ngāi Tahu in accurately identifying and recognising these areas, the mapping of this particular area by Council's GIS consultants has fallen seriously short of meeting a reasonable standard and as a result has caused unnecessary problems and concern for local private landowners and Poutini Ngāi Tahu alike.

It is important to note that the residents and affected property owners do **NOT** oppose the recognition of the actual Paroa Lagoon as being a traditional Matinga Kai (food and other natural resource gathering area) and Ara Tawhito (Traditional Travel route) site.

We wish to advise that the area delineated on the initial maps and consequent changes is **NOT** acceptable to us in the current form.

The boundaries of the new area proposed jointly by the Chairmen of Te Rūnanga o Ngāti Waewae and Te Rūnanga o Makaawhio are more realistic and generally reflect both private landowner and Maori interest in the area. The amended proposed area does not encroach onto private properties fronting the State Highway as previously indicated.

After considerable discussions with Ngāi Tahu representatives on the Te Tai o Poutini Committee it is accepted by both parties that the mapping of the precise proposed boundaries is seriously in error.

We further understand that the errors have occurred between the original mapping by Ngāi Tahu GIS consultants and the Council's GIS mapping consultants because the two systems used were incompatible and hence incorrect boundaries were produced as a result.

The original ellipsoid produced as a result of this mapping system error shows the area of interest overlapping many freehold properties along the east side of the State Highway through the settlement of Gladstone.

It is generally felt that such a designation could cause potential loss in property sales values and additional consent costs in the future if this plan goes ahead in its current format.

As the original intention of Poutini Ngāi Tahu was to include **ONLY** the waterway and immediate coastal area and therefore **NOT** to intrude on private property nor place any planning rules across any properties, this error has caused unnecessary concern for all parties involved.

We have been advised that Poutini Ngāi Tahu will be lodging a submission on the TTPP requesting a change to the current mapped site, because the amending and remedying of the current mapped site was beyond the scope of the minor amendment planning process.

The affected residents find it incredulous that this error created by the planners cannot be simply corrected without residents having to go through the needless stress of the submission process.

Our suggestion, in discussion with Poutini Ngāi Tahu, is that the eastern-most boundary of the proposed SASM 68 – Paroa Lagoon be the existing channel's eastern water's edge which is readily definable from aerial photographs or GPS data gathering.

Either way this would be the most expedient and transparent way of achieving a mutually acceptable result for all parties.

It is also noted that the RMA states that because SASM are considered a type of historic heritage, the rules associated with them have legal effect from the time the proposed TTPP was notified'

This is totally rejected by the affected private landowners, who are submitting and requesting that these rules be withdrawn from the private properties identified.

#### REQUIREMENTS

1. That the eastern boundary of the designated SASM 68 be amended and realigned to the Paroa Lagoon waterway eastern edge.
2. That any proposed references, rules, or conditions, placed on any private property fronting the State Highway be withdrawn immediately.
3. New large scale maps accurately showing this new boundary delineation be produced and supplied to all affected parties for approval.
4. Any rules with **immediate effect** be withdrawn from the currently affected private properties.
