Land within the Queenstown Lakes District at the boundary with Westland District is located within the Rural Zone and is predominantly classified as Outstanding Natural Landscape or Outstanding Natural Feature. The Queenstown Lakes District Proposed District Plan identifies the significance of these landscapes to the social, economic, cultural and environmental wellbeing of communities within Queenstown Lakes. Given this, it is considered important that the Plan notifies users to potential cross boundary resource management issues within the relevant Zones in addition to the relief requested at row 1 above.

In particular, it is noted that the Open Space Zone provides for a number of activities, such as mineral prospecting and extraction, that have the potential to give rise to adverse effects on land within the Queenstown Lakes District if cross boundary issues are not managed effectively.

It is observed that advice notes are included for some activities such as Mineral Prospecting and Mineral Exploration (OSZ-R11), and Agricultural, Horticultural or Pastoral Activities (OSZ-R12) which highlight other obligations on plan users.

Provision OSZ-R11 provides for Mineral Prospecting and Mineral Exploration as a permitted activity, subject to standards. Provision OSZ-R19 specifies that some Mineral Prospecting and Mineral Exploration (including Mineral Extraction) are provided for as Restricted Discretionary activities, in particular if they are not located in or on an Outstanding Natural Landscape or Outstanding Natural Feature. However, it is not clear if it is intended that these activities also be excluded from the permitted activity status in OSZ-R11 if they are located in or on Outstanding Natural Landscapes or Outstanding Natural Features. Queenstown Lakes District Council has an interest in the intent of these provisions on account of potential cross boundary issues that could arise on land within the Queenstown Lakes District. Further, it does not appear that the reference to Mineral Extraction activities in OSZ-R19 contains a permitted baseline despite reference to one in the title of the rule.

Proposed District Plan do not have any legal effect within the Westland District, it is noted that Tangata Whenua may have common interests between these boundaries that may be appropriate to take into account in the development of the Plan.

The advice note would help to manage any cross boundary resource management issues that may come about in relation to Wāhi Tūpuna site 6 (Makarore & Tiore Pātea).




Figure 1: Location of Wāhi Tūpuna site 6 (Makarore & Tiore Pātea) (shown as the green shaded area). The boundary between the QLDC and WDC is shown by the extent of the yellow zone boundary.

Re Queenstown Lakes District Council Submission on Proposed Te Tai o Poutini Plan

- Queenstown Lakes District Council (QLDC) generally support the Proposed Te Tai o Poutini Plan (the Plan). The proposed approach to combing district plans for the West Coast territorial authorities is innovative and QLDC commends the respective council's in producing the document.
- 2. QLDC share an extensive boundary with Westland District Council (WDC). This boundary is primarily located to the north and west of the Queenstown Lakes District (QLD) and mostly traverses land that is held within the public conservation estate. There are currently no urban environments or other strategic urban growth areas that cross, or are located in close proximity to, the QLD boundary with WDC. Despite this, the significant landscape, biodiversity, and visual amenity values associated with conservation land is known to play a significant role in providing for the social, economic, cultural and environmental wellbeing of the QLD. As such, QLDC have an interest in how the Plan intends to manage cross boundary resource management issues if they arise.
- 3. QLDC has prepared a submission that seeks a small number of amendments and clarifications on matters relating to cross boundary resource management matters. The submission form and points of relief are attached to this letter.
- 4. QLDC officers would be happy to provide clarification or answer any questions on the points of relief that have been raised in the submission.
