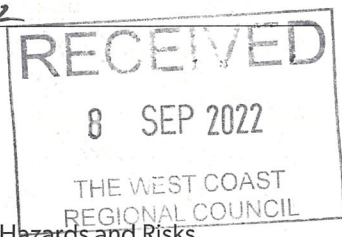

My submission:

① Zoning - Nelson Creek Township - my home is literally straddling two different settlement zone categories, Request amending to a single zone according to land title boundaries.

② Historical and Cultural Values
Nelson Creek Township has history - not mentioned in plan - it is primarily a Township arising from 1800's gold mining, including many different immigrant groups eg. Chinese, Irish, Polish.

There is much evidence of this gold mining history preserved, but nothing noted in this draft document of the District Plan

Nelson Creek Township is fortunate that it has a preserved rebuilt from original design plans an old swingbridge, which has tunnel entrance from 1800's built to give the goldminers access to the goldfields from the settlement areas. It crosses the Nelson Creek river, to the popular recreational walking tracks and recreational gold mining area. Coll's Dam is historic here, as it supplied water for the gold miners.

Recommend this to be mapped as a Historic Reserve with Recreation, as it is currently.
