

Public Notification of Summary of Submissions on Variation 2 to the Proposed Te Tai o Poutini Plan the Combined District Plan for the West Coast – Coastal Natural Hazards Mapping

Te Tai o Poutini Plan (TTPP) Committee gives public notice as required by clause 7 Schedule 1 of the Resource Management Act 1991, of the availability of a summary of decisions requested by persons making submissions on Variation 2 to the Proposed Te Tai o Poutini Plan.

Variation 2 relates to the updated mapping of coastal natural hazards in the proposed TTPP. Submissions on the Variation closed on 30 August 2024. Any further submission made must be limited to supporting or opposing a given submission.
