

**Public Notice of Variation to Proposed Te Tai o Poutini Plan (TTPP)
the Combined District Plan for the West Coast
Clause 5 and 16A of Schedule 1 of the Resource Management Act 1991**

The TTPP Committee gives public notice of the following variation to the proposed plan (the **Variation**):

Variation 2: Coastal Hazards

This variation relates to updating the mapping of coastal hazards and the associated objectives policies and rules in the proposed TTPP. The variation may be inspected on the TTPP website at <https://tpp.nz> or at the following locations:

Please note that following public concern expressed over the initial notification of Variation 2 in June 2024, the TTPP Committee has agreed to renotification of the Variation.

Making a submission on Variation 2 to the Proposed Te Tai o Poutini Plan

Any person, including local authorities, may make a submission on Variation 2 of the proposed Te Tai o Poutini Plan. There are some limitations on the ability of trade competitors, which can be found in clause 6 of Schedule 1 of the RMA. The Variation is a publicly notified one on which all may submit. All submissions on Variation 2 when it was previously notified will be carried over and submitters may either add to that Submission or lodge a new submission.
