The link on the website leading to the Map which deems our property affected will not load and the information sent to us upon request does not have the appropriate colour code key for us to identify what is being proposed for our property.  We need more information and in particular on the heights in which you are expecting Raleigh creek level to rise to deem our property 'affected'.  Raliegh Creek is a very low flow estuary creek as opposed to being a torrent. It would have to rise substantially and at the very least, approximately 6 metres or more and even if it was to rise to such a substantial level it would still not pose any inundation or flooding risks for our property in question.
